The Governor of Punjab is pleased to make following amendments in Fiscal Incentives for Industrial Promotion-2013' notified vide No.CC/FIIP/2013/5343 dated 05.12.2013:-

- (i) **Clause 5.1.6 (a) of Chapter-5 of Fiscal Incentives for Industrial Promotion - 2013 (FIIP-2013) shall be substituted as under:-**

"Date of Approval shall be;

(a) the date of issue of Letter of Regulatory Clearances - I (LoRC-I) by the Bureau;

Or,

(b) In case all the regulatory clearances/ approvals contained in LoRC-I have already been obtained prior to the date of application to the Bureau, the date of the last such approval."

- (ii) **Clause 5.1.17 of Chapter-5 of Fiscal Incentives for Industrial Promotion -2013 (FIIP-2013) shall be substituted as under:-**

"A sum equal to 0.25% of the verified Fixed Capital Investment (FCI) shall be contributed, in equal proportion i.e.0.125% each, to the Punjab State Cancer & Drug Addiction Treatment Infrastructure Fund, constituted under Section 4 of the Punjab State Cancer & Drug Addiction Treatment Infrastructure Fund Act,2013 and to the Punjab Ancient, Historical Monuments, Archaeological Sites and Cultural Heritage Maintenance Board Fund, constituted under Section 5(2)(v) of the Punjab Ancient, Historical Monuments, Archaeological Sites and Cultural Heritage Maintenance Board, 2013. The unit shall deposit the amount before the issue of eligibility certificate."

- (iii) The words "**which have obtained term loan from a Financial Institution /Bank**" from clause 7.4.2 and 7.4.3 of Chapter-7 shall be omitted,
