No LAC/Acq./Hind Terminal/197/Ldh/4682-A Whereas, preliminary Notification No. LAC/Acq./Hind Terminal/197/Ldh/ 15661-A dated 27.12.2018 was issued under Section 11 of "*The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013*" for acquisition of land for the public purpose namely for process of "Developing Integrated Multimodal Logistics Park with a Rail Siding at Village Kila Raipur, Sub-Tehsil Dehlon, District Ludhiana, Punjab" This notification was published in the Punjab Government Gazette dated 18.01.2019 and in the two daily newspapers "The Tribune" (English version) dated 02.01.2019 and "Ajit" (Punjabi version) dated 02.01.2019 The Public Notice regarding the substance of this notification in local language (Punjabi) was got published in the locality through Patwari halka. This notification was also uploaded on the portal of Department of Industries & Commerce, Punjab.

Whereas, Governor of Punjab is satisfied that the land specified below is needed by the Government at public expenses for public purpose, namely for process of "Developing Integrated Multimodal Logistics Park with a Rail Siding at Village Kila Raipur, Sub-Tehsil Dehlon, District Ludhiana, Punjab". In this connection based on Census Survey of the affected families, a Rehabilitation and Resettlement Scheme was prepared as per provisions of Section 16 of the said act by the Administrator-cum- Sub-Divisional Magistrate Ludhiana (East) which was reviewed by the Collector, Land Acquisition and then submitted to the Commissioner as per the provisions of section 17 of the Act.

Whereas, Commissioner, Rehabilitation and Resettlement, Patiala has approved the R&R Scheme on dated 16.04.2019 and forwarded the said report to be made available to the Public, It was uploaded on the website of Punjab Government on dated 24.04.2019 as per section 18 of the said act. The summary of Rehabilitation and Resettlement Scheme includes benefits such as choice of annuity at the lump sum rate of Rs. 5,00,000 to each affected family Resettlement Allowance of Rs. 50,000 and stamp duty registration fee shall be borne by the requiring body.

This declaration is made under the provisions of the Section 19(1) of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" to whom it may concern and under the provisions of Section 21(1) of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" The Collector Land Acquisition, Department of Industries & Commerce, Punjab, Sector-17, Chandigarh is hereby directed to take possession of the said land.

Plan of the land may be inspected in the office of the Collector Land Acquisition, Department of Industries & Commerce, Punjab, Room No. 202, 17-Bays Building, Sector - 17, Chandigarh.
